Background

The research project "Social Cohesion in Africa" aims to identify patterns of social cohesion in Africa and understand better what binds societies together. It focuses on the impact of national and international policies on strengthening social cohesion and preventing social disintegration. The project examines the interdependencies between social cohesion, specific policy areas and international cooperation, and aims to examine the contribution of social cohesion to sustainable development in Africa.

Furthermore, it seeks to strengthen networks between academics, practitioners and policy makers working on this increasingly relevant topic. To this end it supports and coordinates initiatives such as the Social Cohesion Hub (https://www.socialcohesion.info/) and the Social Cohesion Online Seminar implemented jointly with the World Bank.

Motivation

Social cohesion is associated with overcoming some of the key development challenges our societies are facing today, such as inequality, poverty, polarisation or violent conflicts. In Africa, urbanisation and increased demographic pressures may exacerbate development problems and create new challenges for social cohesion. Despite the importance of social cohesion, we lack the conceptual clarity and empirical evidence to define and support policy measures in support of strengthening social cohesion.

Against this background, the specific objectives of the project consist in:

- (1) bringing together different actors working in the field of social cohesion, by providing a shared understanding of social cohesion and advancing knowledge on how to measure it;
- (2) investigating how social cohesion influences, but also is influenced by, policy measures in specific sectors, and (3) understanding how to improve the effectiveness of measures in development cooperation aiming at strengthening social cohesion as well as how to more precisely assess desired or undesired effects that certain supported policies might have on social cohesion.

Our Understanding of Social Cohesion

Social cohesion is a key concept in academic and policy debates but it remains often vaguely defined. A shared concept is, however, essential to enable exchange and knowledge aggregation. We define the concept as follows:

"Social cohesion refers to the vertical and horizontal relations among members of society and the state that hold society together. Social cohesion is characterized by a set of attitudes and behavioural manifestations that includes trust, an inclusive identity and cooperation for the common good."



We have operationalized this concept in close exchange with our partner Afrobarometer. Relying on Afrobarometer survey data we have been able to assess social cohesion in over 30 African societies. The results of this assessment, described and presented in a joint publication, constitute a major project milestone as the generated data allow for further empirical analysis on the relationship of social cohesion with different policy fields.

Thematic Areas

The project consists of one overarching and four theme-based working packages. In the overarching package (WP0) we bring our interdisciplinary expertise together on issues such as conceptualisation and measurement of social cohesion and the analysis of trends and clusters within the African region. In this WP we also work on overall drivers of social cohesion as well as the impact of policy measures on it with a specific emphasis on the role social cohesion plays in managing the Covid-19 pandemic as well as the long term effects the management of the pandemic might have on social cohesion itself.

The other four WPs aim at generating scientific knowledge and deriving policy recommendations, focusing on the interaction between social cohesion and specific policy areas:

- 1) Inclusive economic development: WP1 focuses on issues connected to structural economic transformation, urbanisation, financial sector development, and foreign direct investment with an emphasis on how to maximise opportunities for sustainable economic development, which in turn can improve social cohesion;
- 2) Social policy, poverty and health: WP2 analyses poverty and health in African societies, and the specific role that different social policies can have in tackling poverty and improving health conditions. This, in turn, can promote both the horizontal and vertical dimensions of social cohesion.
- 3) Values, political institutions and resources mobilisation: WP3 focuses on how cultural factors, such as norms and value-orientation, affect the creation and functioning of political institutions in African societies as well as how political institutions (with a particular emphasis on political regime and processes of democratisation and autocratisation) affect the interaction among citizens and their perception of the state.
- 4) Conflict and societal peace: WP4 analyses how political institutions and regime transitions impact societal peace in postconflict societies and how international support can contribute to fostering social cohesion. A particular focus lies on analysing the effect of local elections on social cohesion.

Our core partners



Afrobarometer, is a pan-African, nonpartisan survey research network that conducts public attitude surveys on democracy, governance, the economy, and society. It is considered the world's leading source of high-quality data on what Africans are thinking.



Together with the World Bank we organise the Social Cohesion Online Seminar Series conceived as meeting point for leading researchers of diverse disciplines, policy-makers and practitioners of national and international organisations to discuss new insights in the area of social cohesion as well as their implications for development cooperation.

Social Cohesion Hub

The Social Cohesion Hub_is a knowledge-sharing platform originally conceived and launched by the "Social Cohesion in Africa" project that aims to bring together those interested in social cohesion. In particular, the Hub encourages dialogue between academics and practitioners working on the topic. In this vein, the Hub aims to promote exchange as well as foster cooperation and discussion between different stakeholder groups. Interest and demand is growing and with it the amount of information on the Hub which lives from the active involvement of its growing community and network.
