A research study (30 pages) (based on primary qualitative data collection) conducted by an individual consultant on how social cohesion is affected in communities hosting Venezuelan refugees in Colombia, taking into account different hosting contexts, including political, historical and demographic diversity. Additional optional activities in this context is the write-up of a policy brief (8 pages) and dissemination activities (primarily in Colombia).

8. Transmission and signature of tenders

The award procedure will be carried out as an e-tendering process using the DTVP platform. The bids must be submitted electronically. Submission by other means, e.g. by post, e-mail, fax or as an attachment to a message via the award platform, is excluded.

No fees are charged for registration on the DTVP platform and submission of the bid via the platform. If a company is not yet registered to use the platform, registration for the free Basic Edition is required:

A qualified electronic signature is <u>not</u> required for the submission of bids including all attachments. All documents to be submitted must be completed in full and include the name of the declarant(s) where provided (text form in accordance with § 126b BGB). As an alternative to text form in accordance with § 126 BGB, the documents can also be printed out, signed manually and uploaded as a pdf or provided with an electronic signature as a pdf. It is important to legibly name the company and the responsible person(s) submitting the declaration (in the case of a pdf signature, therefore, also add the name in written form).

Only bids that have been received on time via the e-tendering platform will be considered. It is pointed out that the timely uploading of bids is the responsibility of the bidder.

If the bidder / tenderer wishes to withdraw or amend a submitted bid, the bidder / tenderer must withdraw the submitted bid - before the deadline - via the award platform. If the bidder wishes to submit an amended bid, he/she must submit it again via the award platform before the expiry of the bid deadline.

Changes and additions to the tender documents are not permitted (Section 38 (10) sentence 1 UVgO) and may lead to exclusion from the procedure.

Incomplete bids may be excluded. IDOS may, in compliance with the principles of transparency and equal treatment, request missing, incomplete or incorrect documents, or have them completed or corrected, or clarify the contents of the application that require clarification, if necessary also several times.

The costs of preparing applications and bids will not be reimbursed. Documents, samples, etc. enclosed with the application or offer shall become the property of IDOS without any claim to remuneration or return.

The terms and conditions of business of the contractor shall not apply. Offers that are based on the contractor's own terms and conditions, in whatever form, shall be excluded from the evaluation.

If the contract value exceeds €30,000, the client will request an extract from the central trade register from the Federal Office of Justice for the bidder who is to be awarded the contract.

11. Bidder questions / Further information on the electronic award procedure (e-award procedure)

Bidders are requested to check immediately after accessing the tendering platform that the tendering documents are complete and whether there are any uncertainties regarding these documents. They should also check whether they can open all files and use their functions without any issues.

If the Bidder believes that the rules in the tendering documents are unclear or that the documents raise issues that could influence the bid preparation process, then he or she should notify the contact point of this situation immediately via the communication area of the tendering platform. Any self-evident ambiguities and inconsistencies of which a bidder fails to provide notification despite being aware of them or due to grossly negligent ignorance will detrimentally affect his or her bid.

Bidders' questions about the tendering process must be submitted in text form via the tendering platform only. All questions and answers of general relevance will be published in anonymised form on this platform. The Client reserves the right in this context to add more specific information to the tendering documents. Questions and answers and any more specific information that have been published on the tender platform are binding for the tendering process and the services to be provided.

Bidders are responsible for using the platform to keep abreast of updates and changes during the course of the tendering process and for amending their own documents accordingly. It is therefore advisable to refrain from sending off the bid too early.

In order to answer any questions about the tendering process as comprehensively as possible, all requests for information must be submitted and will be answered according to the time schedule outlined under point 12. While questions may be submitted after this date, bidders are not guaranteed a response before the expiry of the bid submission deadline.

Bidders are required to communicate with the Client in the form of written questions only, submitted via the tender platform, and to refrain from any other form of contact. The Client will immediately refuse any attempt to establish contact other than in writing via the platform. Information will not be provided over the phone; such information would not be binding even if it were to be issued in this way.

If the Client initially only requests personal declarations as evidence of suitability, then the Client reserves the right to request a reasonable amount of supplementary documentation if it deems this necessary.

13. Exclusion Criteria and Evaluation / Assessment Criteria

- Bidders who do not have any professional research experience (on-site) in Colombia
- Bidders who do not speak Spanish (min. C1)
- Bidders who have not published in English
- Bidders who do not have professional experience in conducting research studies in the thematic area of social cohesion and/or displacement in Colombia (relevant to the study and particularly including qualitative data collection and analysis) at all

The contract as such will be awarded to the most economical bid in accordance with the award regulations for the examination and evaluation of bids (§ 43 UVgO) on the basis of the criteria 55% (40% + 15%) quality of the research proposal and the innovative approach and local embeddedness, 15% experience and suitability of researcher and 30% price in accordance with the evaluation matrix below. A detailed breakdown of the evaluation criteria for each part can be found in Annex 3.
