"Fit for purpose? Revitalizing climate and sustainability issues in the G20 process"

20 March 2019

Background

The G20 is struggling to provide strong support for global climate action and sustainable development. At the 2016 Hangzhou Summit the G20 leaders adopted the "G20 Action Plan on the 2030 Agenda for Sustainable Development" and committed to supporting the Paris Climate Agreement. This strong support for multilateral commitments to climate action and sustainable development appears to be fading. Continuing US opposition to strong multilateral climate policy and the imminent risk of a sidelining of sustainability issues in the G20 calls for new alliances within governments and also between science and policy. In 2019, the G20's support for the United Nations' Climate and Sustainability Summits in September 2019 will be particularly important.

A knowledge hub that seeks to strengthen the science-policy interface is the Think 20 (T20). The T20 has established itself as a network of think tanks and research institutes from G20 countries working on a broad range of topics since 2012. The T20 helps to increase continuity in the G20 process and to strengthen links between its expertise and the G20 work streams. The T20 has established, among others, Task Forces on Climate Change and Environment and on the 2030 Agenda for Sustainable Development. Within the G20, pertinent climate and sustainable development issues are discussed by the Sherpas and Financial Deputies and in the Climate Sustainability Working Group and the Development Working Group. The latter, in particular, was tasked in Hangzhou to "act as a coordinating body and policy resource for sustainable development across the G20". To live up to this mandate, the G20 will need pay attention to new knowledge about the urgency of the climate and sustainable development challenge and reflect on recent political developments to ensure continuity across G20 work streams and presidencies.

Objectives

The expert conference has the following objectives:

- 1. To strengthen the role of the G20 and the T20 as a supporter of sustainable development and climate action and pertinent interlinkages to help bridging policy silos and to support multilateral cooperation to that end.
- 2. To foster exchange between members of different T20 Task Forces and officials of relevant G20 work streams.
- 3. To provide a platform to present and discuss key policy recommendations for sustainable development and climate action across T20 Task Forces and G20 work streams.
